Condo Transfer of Membership /Lease Packet Policy & Procedures

Effective 12.21.2023

Leasing Policies:

- A living unit may not be rented or leased more than twelve (12) times per year
- The minimum allowable lease period shall be trirty (30) consecutive days.
- A lease may not begin sooner than thirty (30) days after the first day of occupancy under the last previous lease.
- The lease must be written, and a fully executed copy must be provided to the Association not less than fifteen (15) days before the beginning of the lease term, together with copies of government issued photo IDs, and the completed Transfer of Membership Application Forms
- Subjeasing or assignment of the lease rights is not allowed
- Only the lessee and the lessee's spouse if any, and their dependent, unmarried children, who live with their parents, may occupy the Living Unit during a lease.
- It is the homeowner's responsibility to provide all the Rules and Regulations to tenants and guests, as all the provisions of the Governing Documents and the Rules and Regulations of the Association will be applicable and enforceable against any person occupying a Living Unit
- Each Living Unit is allotted 8 guest passes per year. The homeowner has the right to limit or groh bit the amount of guest passes their renter is allowed to acquire for the duration of the renter's lease

Leasing procedures

- The transfer fees will be charged to the homeowner's Bonita National member charging account. These fees are NON-REFUNDABLE & are subject to change
- Transfer Fees for a Social Membership (Mandatory)
 - One month: \$400 plus 6,5% applicable tax
 - Two months \$325 plus 6.5% applicable tax
 - Three Five months, \$300 plus 6.5% applicable tax
 - 〇 Six months One year \$250 plus 5.5% applicable tax
- Fransfer fee for a Golf Membership is an additional \$500 plus 5.5% applicable tax
- Transfer of Membership packets received under the required 15 days will be charged an additional \$100 expediting fee, which will be completed within 3 business days.
- Applications that are received incomplete will be returned to the homeowner for completion
- 4 completed application includes (Transfer Packet Checklist).
 - The Bonita National Transfer of Membership Packet (5 pages)
 - Signed Lease Agreement between the homeowner and renter
 - Copy of the drivers' i censes or passports for all occupants
- If the rental property is a multi-family nome, it is the homeowner's responsibility to reach out to the sub-association to inquire if an additional application may be required.
